IF YOU WOULD LIKE A PRINTED RECEIPT, TAXES WILL BE COLLECTED IN THE OFFICE OF THE VILLAGE TREASURER AT THE MUNICIPAL CENTER DURING THE FOLLOWING DAYS AND HOURS:

TAXES MAY ALSO BE PAID DURING NORMAL MUNICIPAL CENTER HOURS-THE BILL WILL BE STAMPED PAID.

**Check or money order is PREFERRED.** Please make checks payable to: **Village of Biron** and write your parcel # on your check. (This number is found in the upper right hand corner of your bill). **If paying in cash, YOU MUST HAVE THE EXACT AMOUNT, INCLUDING CHANGE.** A fee of **\$30.00** will be charged on returned checks for insufficient funds. If a refund is due, it will be made via check and mailed. **Please note overpayments of less than \$5.00 will be refunded only upon request.** We do not accept credit/debit cards. Detach the appropriate stub from the bottom of the tax bill and mail or bring with your payment. Do not staple. Do not leave payment in mailbox.

**PAYMENT MAY BE MADE BY MAIL** through January 31. **IF YOU WOULD LIKE A RECEIPT, INCLUDE A SELF ADDRESSED STAMPED ENVELOPE.** Payments postmarked **December 31 will be processed for December.** Payments postmarked January 31 are accepted as being on time. **Dog licenses are due before March 31.** Bring your rabies certificate, if not current and on record, showing name and serial number of vaccine, date of vaccination, and expiration date. The cost is \$5 if neutered/spayed or \$15 if not. Late fee \$5.00 due per §174.05(5) if license not obtained before April 1.
