<u>Check or money order is PREFERRED</u>. Please make checks payable to: Village of Biron and write your parcel # on your check. (This number is found in the upper right hand corner of your bill). <u>If paying in cash, YOU MUST HAVE THE EXACT AMOUNT, INCLUDING CHANGE</u>. A fee of \$30.00 will be charged on returned checks for insufficient funds. If a refund is due, it will be made via check and mailed. <u>Please note overpayments of less than \$5.00 will be refunded only upon request</u>. We do not accept credit/debit cards. Detach the appropriate stub from the bottom of the tax bill and mail or bring with your payment. Do not staple. Do not leave payment in mailbox.

PAYMENT MAY BE MADE BY MAIL through January 31. IF YOU WOULD LIKE A RECEIPT, INCLUDE A SELF ADDRESSED STAMPED ENVELOPE. Payments postmarked December 31 will be processed for December. <u>Dog licenses are due before March 31</u>. Bring your rabies certificate, if not current and on record, showing name and serial number of vaccine, date of vaccination, and expiration date. The cost is \$5 if neutered/spayed or \$15 if not. Late fee \$5.00 due per §174.05(5) if license not obtained before April 1.
